- _____ 2. Reviewed my qualifications, obligations, and responsibilities under the provisions of Wyoming Statutes §33-41-101 through §33-41-121 and the Rules and Regulations of the Board (enclosed in application packet), particularly as they relate to information required on the application form.
- _____ 3. Requested official transcripts of college course work and verification of degree(s) from all pertinent colleges/universities (Section 2.0 of the application). Colleges/Universities must send these directly to the Board.
- _____ 4. Listed **ALL** my experience correctly, noting full-time/part-time differentials and converting total time to full-time months (Section 4.0 of the application).
- _____ 5. Requested and forwarded professional reference forms to three individuals (respondents), pursuant to the requirements of Section 5.0 of the application. Professional references must send these forms directly to the Board.
- _____ 6. Completed and signed the affidavit (Section 7.0), witnessed and acknowledged by a notary public.
- _____ 7. Completed and signed the Verification of Lawful Presence Form and attached the appropriate documentation.
- _____ 8. Kept copies of all forms for my records.
